Stewards Inquiry Race 2 – Steward's Inquiry into the stretch run in the approaching the 3/16 pole, #4 So Good to Go (Luis Saez) drifted out several paths causing the #3 Star of the Forest (Conelio Velasquez) to take up sharply going on to finish third. After reviewing the video and speaking to the riders involved the #4 So Good to Go was disqualified from first and placed third, the new order of finish was 1-3-4-5. Decision was unanimous.

Race 3 - #5 Cats Landing was scratched on advice of the NYRA Veterinarians.

Stewards Inquiry Race 5 – Steward's Inquiry into the start of the race as #7 Whats Up Big Guy (Kendrick Carmouche) start was compromised in the opinion of the stewards and declared a nonstarter.

Incident Race 7 - #4 Mighty Katherine/Trainer Ian Wilkes was pulled after the finish of the race and taken off the track on the horse ambulance.

Steward's Inquiry and Trainer Objection – Race 6 - Stewards Inquiry and a trainer's objection from the third place finisher #3 Sassicaia(Corneilo Velasquez) against the first place finisher #5 Takajo (Eric Cancel) for alleged interference in the vicinity of the 1/8 pole. After reviewing the race videos and speaking with the riders involved, the objection against # 5 was disallowed. The Steward's inquiry also concerned the second place finisher #2 Juba (Luis Saez). After passing the 1/8 pole, #2 drifted out under a left handed crop causing #3 Sassicaia (Cornelio Velasquez) to steady. In the judgment of the stewards, this incident altered the final placement. #2 Juba is disqualified from second and placed third behind #3 Sassicaia. The new Order of finish is 5-3-2-9. The decision was unanimous.

Steward Inquiry and Jockey's Objection - Race 7 - Stewards inquiry and jockeys objection from the second place finisher #2 Tuttipaesi (Junior Alvarado) against the winner # 5 Recepta (John Velazquez) for alleged interference approaching the 1/16 pole. With room remaining on the rail, # 2 drifted out under a left handed crop and checked as # 5 drifted in slightly while passing. After reviewing the video and speaking the riders involved in the judgment of the stewards the incident did not alter the finish. The objection was disallowed and the race declared official as is 5-2-4-11. The decision was unanimous.

Steward's Inquiry and Jockey's Objection – Race 5 - Christopher De Carlo, the rider of #8 Brevard, lodged an objection against the first place finisher, # 1 Burndines (Irad Ortiz, Jr.) for alleged interference in the stretch. #8 Brevard, racing 2 lengths off #1 Burndines passed the 1/8 pole, moved up on the rail after passing the 1/16 pole and steadied inside #1 nearing the wire as #1 drifted in. After reviewing the race videos and speaking with the riders involved, the objection was disallowed and the race declared official as is.
