MINUTES OF BOARD MEETING
HELD ON AUGUST 12, 1986

A. MINUTES:

1. The Board approved the minutes of its meeting held on July 24, 1986.

B. FOR ENTRY INTO THE MINUTES:

1. NYRA - SARATOGA MEETING. For entry into the minutes, the Board's prior approval of July 23, 1986 of request by New York Racing Association to include steeplechase races with the Daily Doubles offered by NYRA, pursuant to Rule 4011.4; and to use seven pari-mutuel windows in the backstretch at Saratoga.
2. NYRA - WNEW-AM RADIO. For entry into the minutes, the Board's prior approval of July 29, 1986 of request by New York Racing Association to enter into agreement with WNEW-AM Metromedia Radio to broadcast the 8th and 9th race calls on a delayed basis for the period of July 30, 1986 upto and including December 29, 1986, pursuant to Section 4004.5 of the Board rules.
3. NYRA - POCONO DOWNS AND BLUE RIBBON DOWNS. For entry into the minutes, the Board's prior approval of July 29, 1986 of request by New York Racing Association to enter into agreement with Pocono Downs to accept pari-mutuel wagers on the Travers on August 16, 1986; and to enter into agreement with Blue Ribbon Downs to accept pari-mutuel wagers on the Travers on August 16, 1986 and the Marlboro Cup on September 13, 1986.
4. NYRA - NEW JERSEY SPORTS. For entry into the minutes, the Board's prior approval of July 29, 1986 of request by New York Racing Association to enter into agreement with New Jersey Sports Exposition Authority, running a race meeting at the Meadowlands, to accept pari-mutuel wagers on the Travers on August 16, 1986 and the Hopeful Stakes on August 23, 1986.
5. NYRA - PHILADELPHIA TURF CLUB AND COLONIAL RACING. For entry into the minutes, the Board's prior approval of July 29, 1986 of request by New York Racing Association to enter into agreement with Philadelphia Turf Club and Colonial Racing Club to accept pari-mutuel wagers on the Whitney (August 2); the Alabama (August 9); the Travers (August 16); and the Hopeful (August 23, 1986).
6. CAPITAL DISTRICT OTB - LAKE GEORGE. For entry into the minutes, the Board's prior approval of July 21, 1986 of request by Capital District Off-Track Betting Corporation to amend its simulcast plan of operation and add its Lake George branch as a simulcast facility.

7. CAPITAL DISTRICT OTB - TELETHEATER. For entry into the minutes, the Board's prior approval of July 25, 1986 of request by Capital District Off-Track Betting Corporation to amend its simulcast plan of operation with respect to its Albany teletheater and the installation therein of automated betting equipment.
8. NEW YORK CITY OTB - HASKELL INVITATIONAL. For entry into the minutes, the Board's prior approval of July 24, 1986 of request by New York City Off-Track Betting Corporation on behalf of all New York State Regional Off-Track Betting Corporations to accept wagers on the Haskell Invitational on July 26, 1986 at Monmouth Park.
9. NOTICE OF SUSPENSION AND HEARING IN THE MATTER OF - J. KARL LOWES. For entry into the minutes, the Board's prior approval of July 25, 1986 of the Notice of Suspension and Hearing in the Matter of J. Karl Lowes for violation of Board rule 9NYCRR 4120.2 and 4120.4, involving the use of the drug Clenbuterol, based upon the Board's finding that the public's safety and welfare required the emergency action of his immediate suspension from racing.
10. YONKERS RACEWAY - SUGARMAN PRODUCTIONS. For entry into the minutes, the Board's prior approval of July 28, 1986 of request by Yonkers Raceway for an extension of the January 6, 1986 agreement concerning the simulcast of Yonkers Raceway races to the State of Nevada for the period of July 10, 1986 thru and including August 3, 1986.
11. ROOSEVELT RACEWAY - LOUISVILLE DOWNS. For entry into the minutes, the Board's prior approval of August 1, 1986 of request by Roosevelt Raceway to simulcast one race per night, Monday thru Saturday from Monday, August 4, 1986 to and including Monday, September 8, 1986 to Louisville Downs.
12. NYRA - GREEN MOUNTAIN RACING. For entry into the minutes, the Board's prior approval of August 1, 1986 of request by New York Racing Association to enter into agreement with Green Mountain Racing Corporation to accept pari-mutuel wagers on specific days only starting August 4, 1986 thru December 31, 1986.
13. NYRA - FINGER LAKES. For entry into the minutes, the Board's prior approval of August 5, 1986 of request by New York Racing Association to enter into agreement with Finger Lakes Racing Association to accept pari-mutuel wagers on the Travers on August 16, 1986.
14. NYRA - PHILADELPHIA PARK AND PENN NATIONAL. For entry into the minutes, the Board's prior approval of August 1, 1986 of request by New York Racing Association to enter into agreement with Philadelphia Park to accept pari-mutuel wagers on the Woodward on August 30, 1986; and to enter into agreement with Penn National to accept pari-mutuel wagers on the Travers on August 16, 1986.

15. SYRACUSE MILE - LICENSE AMENDMENT. For entry into the minutes, the Board's prior approval of August 1, 1986 of request by Syracuse Mile to make various changes and additions to their 1986 track license, as outlined in their letter of July 7, 1986.
16. BATAVIA DOWNS - "WIN A HORSE FOR A NIGHT". For entry into the minutes, the Board's prior approval of August 5, 1986 of request by Batavia Downs to offer a promotion called "Win a Horse for a Night", to run two or three times during their current meeting with the first on August 15, 1986 as outlined in their letter of August 1, 1986.
17. BUFFALO RACEWAY - ERIE COUNTY FAIR. For entry into the minutes, the Board's prior approval of August 1, 1986 of request by Buffalo Raceway to simulcast thoroughbred races from Saratoga during nine days of the ten day Erie County Fair which will be held from August 8, 1986 through August 17, 1986, (Saratoga is dark on August 13, 1986).
18. YONKERS RACEWAY - LOUISVILLE DOWNS. For entry into the minutes, the Board's prior approval of August 1, 1986 of request by Yonkers Raceway to simulcast the sixth race on August 2, 1986 to Louisville Downs.
19. FINGER LAKES - COLE BROTHERS CIRCUS. For entry into the minutes, the Board's prior approval of August 1, 1986 of request by Finger Lakes Racing Association to have the Cole Brothers Circus at Finger Lakes from August 12, 1986 thru August 17, 1986.
20. SUFFOLK MEADOWS - SPECIAL REDUCED ADMISSION. For entry into the minutes, the Board's prior approval of August 1, 1986 of request by Suffolk Meadows Race Track to promote in an August 1st Newsday ad, a "Special Reduced Admission" price for August 1, 2 and 3, 1986 whereby the price will be \$1 Grandstand and \$2 Clubhouse.
21. WESTERN REGIONAL OTB - PICK-THREE. For entry into the minutes, the Board's prior approval of July 30, 1986 of request by Western Regional Off-Track Betting Corporation to conduct pick-3 wagering on Batavia Downs and to broadcast live calls into branch offices.
22. EMERGENCY RULE - PICK-SIX. For entry into the minutes, the Board's prior approval of August 8, 1986 of the Emergency Rule which was submitted regarding a Pick-Six consolation prize in thoroughbred racing, pursuant to legislation enacted.

C. FOR BOARD APPROVAL:

1. NYRA - BEULAH PARK. The Board approved the request by New York Racing Association to enter into agreement with Beulah Park to accept pari-mutuel wagers on the Woodward (August 30); the Marlboro Cup (September 13); the Turf Classic (September 20); the Jockey Club Gold Cup (October 4); and the Man O' War (October 11, 1986).

2. NYRA - BEULAH PARK. The Board approved the request by New York Racing Association to enter into agreement with Beulah Park to accept pari-mutuel wagers on the Ruffian Handicap (September 21); the Beldame Handicap (October 12); the Champagne (October 18); the Ladies Handicap (November 16); the Remsen (November 22); the Vosburgh (November 29); the Bertram Bongard (December 6); the Nashua (December 13); and the Tempted (December 14, 1986).
3. BATAVIA DOWNS - DELETE NOVEMBER 25, 1986. The Board approved the request by Batavia Downs to delete November 25, 1986 as a racing date.
4. FINGER LAKES - REGISTER RECEIPTS. The Board approved the request by Finger Lakes Racing Association to print a coupon good for one free admission on the back of supermarket cash register receipts in two Bell stores in Rochester, to appear during the months of September, October and November.
5. NYRA - LOUISIANA DOWNS. The Board approved the request by New York Racing Association to enter into agreement with Louisiana Downs to accept pari-mutuel wagers on the Travers on August 16, 1986.
6. NYRA - MARYLAND JOCKEY CLUB. The Board approved the request by New York Racing Association to enter into agreement with the Maryland Jockey Club of Baltimore, running a race meeting at Pimlico Race Course, to accept pari-mutuel wagers on the Travers on August 16, 1986.
7. NYRA - PHILADELPHIA TURF CLUB AND COLONIAL RACING CLUB. The Board approved the request by New York Racing Association to enter into agreement with Philadelphia Turf Club and Colonial Racing Club to accept pari-mutuel wagers on the Marlboro Cup on September 13, 1986 and the Turf Classic on September 20, 1986.
8. IN THE MATTER OF ALAIN de ROYER DUPRE. The Board approved the Counsel's recommendation that the charges against trainer Alain de Royer Dupre be dismissed and that Lashkari and Shernazar be restored to their original place in order of finish.
