Re: Temporary Permit

Dear Mr. Ritchie:

On August 22, 2017, the New York State Gaming Commission ("Commission"), having determined that Fulltime Fantasy Sports, LLC ("Applicant") meets each of the requirements set forth in sections 1402 and 1404 of the Racing, Pari-Mutuel Wagering and Breeding Law to hold a temporary permit to offer interactive fantasy sports contests, hereby provides this temporary permit for Applicant to offer interactive fantasy sports contests in New York State, on a provisional basis, subject to the following conditions:

1. The material submitted in connection with Applicant's Interactive Fantasy Sports Contest Application for a Temporary Permit is accurate and not misleading.
2. Applicant shall comply with all applicable provisions of Article 14 of the Racing, Pari-Mutuel Wagering and Breeding Law and any amendments thereto, as determined by Commission;
3. Applicant shall remit all payments to the State pursuant to Article 14 of the Racing, Pari-Mutuel Wagering and Breeding Law according to any instruction or direction of the Gaming Commission;
4. Applicant shall file an application for registration within 90 days of the promulgation of regulations to effectuate the registration process, as required by paragraph (b) of subdivision 1 of section 1402 of the Racing, Pari-Mutuel Wagering and Breeding Law; and

5. Applicant is permitted to offer in New York State only those types of games and contests, as set forth in the Appendix attached hereto, that Applicant offered to the public in New York State prior to November 10, 2015.

This temporary permit is not assignable and shall be effective until 90 days following the promulgation of regulations to effectuate the registration process to offer interactive fantasy sports in New York State or, if Applicant applies to be an interactive fantasy sports registrant in New York State, then this temporary permit shall be effective until Applicant is registered as an interactive fantasy sports operator pursuant to Racing, Pari-Mutuel Wagering and Breeding Law section 1402 or Applicant's application for registration as an interactive fantasy sports operator pursuant to Racing, Pari-Mutuel Wagering and Breeding Law section 1402 is denied.

## Appendix

For each of the National Football League contests in which contestants select a roster of players and statistics for selected players are aggregated pursuant to announced scoring rules to determine contest outcomes, in the following formats:

**Fantasy Football World Championship**-The Fantasy Football World Championships (FFWC) will consist of a maximum of 125 leagues, each composed of 12 teams/managers. The FFWC regular season will extend from NFL Week 1 through NFL Week 13.

**Fantasy Football Online Championship**-The SCOUT Fantasy Online Championships will consist of a maximum of 416 leagues (In 2016, this contest had 92 leagues), each composed of 12 teams/managers. The SCOUT Fantasy Online Championships regular season will extend from NFL Week 1 through NFL Week 13

**Dynasty Football World Championship**-13 week Regular Season, in which Weeks 1 and 2 will be All-Play. In each league, the top 6 scoring teams get a win each week and the bottom 6 scoring teams get a loss each week. Weeks 3-13 will be head to head against each league member. The 4 top teams automatically qualify for the Dynasty World Championship Round.

**Qualifier Leagues**-These World Championship Satellites follow the same rules as the FFWC.

**DraftnGo**-Contestants form leagues that require no in-season management. Contestants draft players and have their rosters optimized from drafted players each week for the best possible start.

**Starter Leagues**-Scout Starter Fantasy Football Leagues are offered in three (3) different varieties.

Full Season – Contestants set weekly lineups and add weekly free agents. (18 man rosters - 18 rounds of drafting)

Draft Only Contestants exclusively draft players. (24 man rosters - 24 rounds of drafting)

QB SuperFlex Draft Only – Follows Draft only rules but contestants can use a QB in the FLEX position.
