This Statement of Work ("SOW") includes requested services in accordance with the Gaming Market Study #C190013V2 entered into by and between the New York State Gaming Commission (the "Commission"), and Spectrum Gaming Group.

Commencement Date: Upon approval of the Office of State Comptroller

Estimated Completion Date: June 30, 2020

Estimated Cost: \$47,000

Detailed description of work to be performed, staffing, pricing, and deliverable:

The final report shall clearly and distinctly reflect the impact of COVID-19. Specifically, whether the financial projections in the report reflect any impact from the pandemic and upon what assumptions these impacts were based.

Given that Governor Andrew M. Cuomo has articulated a regionally phased approach in which commercial casinos and video lottery gaming facilities might open, the report shall reflect the short-term potential market change for casinos and video lottery gaming as some may open sooner than others; the potential impact of social distancing; forecast when patrons may be reasonably expected to return to facilities; and when a return to pre-COVID-19 attendance be expected, if at all; implications to the three potential additional downstate licenses; and impact on revenue expectations for iLottery, mobile sports wagering and iGaming due to the pandemic.
