Stewards Inquiry and Jockey Objection Race 2- Inquiry in the vicinity of the 3/8 pole, #3 Judge Maggie (Emanuel De Diego) broke down in the area. After reviewing the race video the Stewards made the race official as is.

Equine Death Race 5- #3 Judge Maggie trained by Timothy Murphy and ridden by Emanuel De Diego was pulled up at the 3/8 pole and suffered a fracture to the right front limb and was humanely euthanized on track.

Horses Claimed- Race 7- #3 New York's Zip Claimed by Trainer Thomas Muller, Sr. for Linda and Thomas J. Muller, Sr.; Race 8- #2 Gratifying Claimed by Trainer Joseph Cabrera for Joseph Cabrera

Ruling- Eduardo Maver, Jr.- Owner-Trainer- Having received a report from the NYS Gaming Commission Equine Drug Testing Laboratory of the finding of *orphenadrine* and metabolites of orphenadrine in the body fluid sample taken from the horse #1 Jomary's the Great which finished second in the 6th race on August 28, 2017 at Finger Lakes Racetrack, in violation of 9 NYCRR §§ 4043.2 and 4043.4(a), and having waived his right to appeal, Owner/Trainer Eduardo Maver is suspended for 15 calendar days effective Tuesday, October 24, 2017 through November 7, 2017, inclusive, and fined \$500.

Stewards Inquiry Race 8- Inquiry into the start, #4 Not About the Nail (Alexis Valdes) stumbled and unseated the rider. #4 Not About the Nail continued on without the rider and interfered with the leaders in the stretch. After reviewing the race video in the judgment of the Stewards this incident altered the finish of the race and declared the race a No Race and refunded all wagers.

Incident Race 8- #4 Not About the Nail trained by Luis Gutierrez and ridden by Alexis Valdes stumbled at the start and unseated the rider.

Stewards Inquiry and Jockey Objection Race 7- Jockey of the second place finisher #3 Beyond Discreet (Rodolfo Ignacio) claimed foul against the first place finisher #5 Traipse In Utopia (Emanuel De Diego) for alleged interference in the stretch. After reviewing the race video and speaking to the riders involved the Stewards disqualified #5 Traipse In Utopia from first and placed him second. New order of finish: 3, 5, 2, 4, 7, 1A, 6.
