Stewards Inquiry and Jockey Objection Race 2- Jockey of the third place finisher #5 Only the Silk (Jose Gutierrez) claimed foul against the first place finisher #4 George Grammas (Michael Davila, Jr. for alleged interference in the stretch. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident altered the finish of the race and #4 George Grammas is disqualified from first and placed third. New order of finish: 3, 5, 4, 1, 6, 7, 2, 8.
