Stewards Inquiry and Jockey Objection Race 2- Jockey of the second place finisher #6 Approval (Joel Sone) claimed foul against first place finisher #4 Riveressed (Harry Hernandez) for alleged interference in the stretch. During the stretch run #4 Riveressed drifted out and interfered with #6 Approval. After reviewing the race video and speaking with the riders involved in the judgment of the Steward this affected the outcome of the race and #4 Riveressed is disqualified from first and placed second. New order of finish: 6, 4, 5, 3, 2, 1.

No Incidents Occurred

Jockey Movie Review Race 2- Stewards Stuart Rainey, Rick Coyne and Don Combs met with rider Harry Hernandez to review his ride on #4 Riveressed. After review of the race the Stewards determined Harry Hernandez was held blameless.
