**Stewards Inquiry and Jockey Objection Race 7-** Jockey of the seventh place finisher #7 Tropical Joy (Jacqueline Falk) claimed foul against third place finisher #8 Surprise Cameo (Jaime Rodriguez) for alleged interference at the start. After reviewing the race video the Stewards made the race official as is.

No Incidents Occurred

**Horses Claimed-** Race 5- #10 Queen of New York Claimed by Trainer Leon McKanas for Leon McKanas

**Ruling- Daniel J. Poliziani- Owner-Trainer-** Having received a report from the NYS Gaming Commission Equine Drug Testing Laboratory of the finding of methocarbomal and guaifenesin in the body fluid sample taken from the horse "Jolson" (#1A) which finished 2nd in the second race on May 2, 2016, and having waived his right to appeal, Owner/Trainer Daniel J. Poliziani is suspended for 30 days reduced to 15 days; effective Sunday, June 5, 2016 through Sunday, June 19, 2016, inclusive, and fined \$500.00 reduced to \$250.00.

Furthermore, "Jolson" is disqualified from any part of the purse and the stewards order the purse redistributed as follows: 1. (#3) Stop Sign, 2. (#2) Green Diamond Cat, 3. (#4) My Way or Dubaiway, 4. (#5) Park City
