Stewards Inquiry Race 1- Inquiry into the stretch, #4 National Buck (Jeremias Flores) drifts out in the vicinity of the 1/16 pole and impedes #5 Party On (Hector Berrios). After reviewing the race video and speaking with all riders involved in the consensus of the Stewards the incident altered the finish of the race and #4 National Buck is disqualified from first and placed second. New order of finish is 5, 4, 2, 3, 1.

Stewards Inquiry and Jockey Objection Race 2- Jockey of the third place finisher #4 Unbridled Band (Guillermo Rodriguez) claims foul against second place finisher #2 Chasin Chama (Oscar Gomez) for alleged interference in the stretch. In the vicinity of the 1/16 pole #2 Chasin Chama drifted out and impeded #4 Unbridled Band. After reviewing the race video and speaking with all riders involved in the consensus of the Stewards the incident altered the finish of the race and #2 Chasin Chama is disqualified from second and placed third. New order of finish is 5, 4, 2, 1, 6, 3.

Stewards Inquiry and Jockey Objection Race 4- Jockey of the sixth place finisher #4 Miz Sweet (Oscar Gomez) claims foul against fifth place finisher #2 Rose of Sicily (Guillermo Rodriguez) for alleged interference in the stretch. In the vicinity of the 1/16 pole #2 Rose of Sicily drifted in and impeded #4 Miz Sweet. After reviewing the race video and speaking with all riders involved in the consensus of the Stewards the incident altered the finish of the race and #2 Rose of Sicily is disqualified from fifth and placed sixth. New order of finish is 3, 6, 1, 5, 4, 2, 7.

Equine Death Race 6- July 11, 2015- #3 Retaking trained by Luis Gutierrez and ridden by Guillermo Rodriguez was found to have a racing related fracture of the left front ankle from July 11 and was humanely euthanized on July 16.

Stewards Inquiry and Jockey Objection Race 9- Jockey of the fourth place finisher #6 Golden Nugget (Gabriel Suarez) claims foul against the third place finisher #2 Roar of Raul (Kevin Roman) for alleged interference in the vicinity of the 1/4 pole. After reviewing the race video, speaking with all riders involved and noting that the video which could be seen was inconclusive, in the consensus of the Stewards no action was warranted.

Ruling- Guillermo Rodriguez- Jockey- "Rose of Sicily" (#2), ridden by Jockey Guillermo Rodriguez, was disqualified from fifth position and placed sixth for interfering with "Miz Sweet" (#4) in the stretch, during the running of the 4th race on Thursday, July 16, 2015. Having waived his right to appeal, Jockey Rodriguez is suspended for 3 racing days effective Saturday, July 18, 2015; Monday, July 20, 2015 and Tuesday, July 21, 2015.

Stewards Inquiry and Jockey Objection Race 5- Jockey of fifth place finisher # Wild Hardships (Rodolfo Ignacio) claims foul against third place finisher #1 Essence at Noon (Luis Perez) and fourth place finisher #2 Meetinghouse Road (Hector Berrios) for alleged interference at the start. After reviewing the race video and speaking with all riders involved in the consensus of the Stewards no action was warranted.

Equine Death Race 8- #4 Imposing Figure trained by Chris Englehart and ridden by Jose Rohena was pulled up at the 1/2 mile pole and taken off on the horse ambulance and was later humanely euthanized.

No Claims Occurred

Ruling- Oscar Gomez- Jockey- "Chasin Chama" (#2), ridden by Jockey Oscar Gomez, was disqualified from 2nd position and placed 3rd for interfering with "Unbridled Band" (#4) in the stretch, during the running of the second race on Thursday, July 16, 2015. Jockey Oscar Gomez is suspended for three racing days effective Friday, July 24, 2015; Saturday, July 25, 2015, and Monday, July 27, 2015.
