Stewards Inquiry and Jockey Objection Race 5- Jockey of third place finisher #1 Bubbe Zena (Jeremias Flores) and jockey of fourth place finisher #8 She's Roman (Jaime Rodriguez) claimed foul against first place finisher #4 Saratoga Swag (Alexis Valdes) for alleged interference in the stretch. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards #4 Saratoga Swag was disqualified from first and placed fourth. New order of finish: 6, 1, 8, 4, 2, 5, 3, 7.

Equine Death Race 3- #4 Indiana Stones trained by Paul Barrow and ridden by Gabriel Suarez was taken off on the horse ambulance after the finish of the race and was later humanely euthanized.

Equine Death Race 4- #2 Sgt. Major Ross trained by Samuel Morales and ridden by Harry Hernandez was pulled up in the stretch and taken off on the horse ambulance and was later humanely euthanized.

Jockey Movie Review Race 5- Stewards Stuart Rainey, Rick Coyne and Don Combs met with riders Alexis Valdes, Jeremias Flores and Jaime Rodriguez regarding the stretch run of the race. After review the Stewards suspended rider Alexis Valdes for three racing days.
