**Stewards Inquiry and Jockey Objection Race 5-** Jockey of the second place finisher #1 Here We Go Joe (Luis Perez) claims foul against the first place finisher #5 French Wine (David Lopez) for alleged interference in the stretch. After reviewing the race video and speaking with all riders involved the Stewards found no reason for any change and the race is made official as is.

**Horses Claimed-** Race 7- #1 Jazzington Claimed by Trainer Luis Gutierrez for Luis Gutierrez

**Rulings- Jacqueline L. Stauffer- Owner Renewal-** Fined \$100 reduced to \$50 in consideration of no further violation of the rules, for using abusive language toward a fellow licensee.

**Ilmar A. Loaiza- Owner- Trainer-** Having received a report from the NYS Gaming Commission Equine Drug Testing Laboratory of the finding of *orphenadrine* in the body fluid sample taken from: "My Honey Laurie" which finished 1st in the third race on July 18, 2015; "Ms Eileen" which finished 2nd in the eighth race on July 27, 2015; "Tinasutopianvision" which finished 1st in the eighth race on August 13, 2015; "I the Pappy Boss" which finished 2nd in the sixth race on August 14, 2015; "Ta Bueno" which finished 3rd in the fifth race on August 15, 2015; In previous rulings the above horses have been disqualified from any part of the purses and the purses distributed. Owner/Trainer Ilmar Loaiza is hereby suspended for 60 calendar days and fined \$2,500, this case is referred to the NYS Gaming Commission for any increased penalty which the Commission may deem appropriate. Having appealed, a stay of the license suspension or revocation is hereby granted; however, Commission counsel may make a motion for the stay to be terminated in the event that the appeal hearing is not completed within 90 days of this ruling. If the stay is terminated because of an unreasonable delay in the completion of the hearing, then the license suspension or revocation would begin and run until the appeal hearing is completed. The licensee is also hereby granted a separate stay that will begin only after the appeal hearing is completed. This second stay will terminate when the Commission issues its final agency action (e.g., finding and order).

Furthermore, "Ronnie's Whey" is disqualified from any part of the purse and the stewards order the purse redistributed as follows: 1. (#10) Can'tcatchjack, 2. (#3) Essence At Noon, 3. (#7) Royal Silk, 4. (#8) U So Grand, 5. (#11) My Mojo, 6. (#9) Rally for McNally, 7. (#2) Have Another Look, 8. (#5) Royalty Reigns, 9. (#6) Here's Trance
