Stewards Inquiry Race 5- Inquiry into the stretch run, #4 Road to Perfection (Eric Cancel) racing on the outside with #6 Smile Big (Irada Ortiz, Jr.) on the inside brush in the vicinity of the 1/8 pole. Then #4 Road to Perfection shifts out in the vicinity of the 1/16 pole then #6 Smile Big reacting to a left handed crop comes out to #4 Road to Perfection and makes contact. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards no further action was necessary. Decision was unanimous.

Incident Race 9- Horse Dublin Leprechaun trained by John Hertler kicked rider Harry Hernandez in the paddock prior to the race and was scratched by the Stewards.

Jockey Movie Review Race 5- Stewards Stephen Lewandowski, Hugh Gallagher and Jim Edwards met with riders Irada Ortiz, Jr. and Eric Cancel regarding the incidents in the Stewards Inquiry in the race. After review the Stewards issued a warning to both Irada Ortiz, Jr. and Eric Cancel to make a strong effort to maintain a straight course.
