**Steward Inquiry Race 9-** Inquiry into the start, #4 Memory Keeper (Jose Ortiz) stumbled badly at the start unseating his rider. #2 Freedom Seven (Harry Hernandez) ducked out sharply leaving the gate bumping with #4 Memory Keeper and causing his rider to lose his stirrups. After reviewing the race video the Stewards made the race official as is. Decision was unanimous.

**Incident Race 9-** #4 Memory Keeper trained by Thomas Morley and ridden by Jose Ortiz unseated the rider after the start of the race and was taken to first aid for evaluation.

**Stewards Inquiry and Jockey Objection Race 1-** Jockey of the second place finisher #2 Tom's Gift (Jose Ortiz) claims foul against first place finisher #6 Catamount Junior Alvarado for alleged interference in the stretch. In the vicinity of the 1/16 pole #6 Catamount reacting to a right handed crop drifts in making contact with #2 Tom's Gift slowing his momentum. After reviewing the race video and speaking with all the riders involved in the judgment of the Stewards this incident altered the finish of the race and #6 Catamount is disqualified from first and placed second. Decision was unanimous. New order of finish: 2, 6, 5, 4, 3, 1.

**Stewards Inquiry and Jockey Objection Race 4-** Jockey of the second place finisher #1 Panfila (Jaime Rodriguez) claims foul against first place finisher #7 Midnight Champagne (Cornelio Velazquez) for alleged interference in the stretch. In the vicinity of the 3/16 pole #7 Midnight Champagne while clear shifts to the inside while passing #1 Panfila. After reviewing the race video and speaking to all the riders involved in the judgment of the Stewards no action was warranted. Decision was unanimous.

**Incident Race 6-** #8 Tiz Time to Shake trained by Doodnauth Shivmangal and ridden by Harry Hernandez was pulled up and taken off on the horse ambulance.
