**Stewards Inquiry Race 4-** Inquiry into the stretch run, in the vicinity of the 1/8 pole #6 Unbridled Juan (Irada Ortiz, Jr.) drifts out and #4 Doyouknowsomething (Javier Castellano) has to steady. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this altered the finish of the race and #6 Unbridled Juan is disqualified from second and placed third. Decision was unanimous. New order of finish: 2, 4, 6, 1, 3, 5.

**Stewards Inquiry Race 9-** Inquiry into the top of the stretch run, #7 Silly Numbers (Jose Lezcano) runs up behind a wall of horses and clips hills with #3 You Promise (Mike Luzzi) causing that horse to stumble and lose her rider. After reviewing the race video in the judgment of the Stewards no further action is warranted and the race is official as is. Decision was unanimous.

**Incident Race 9-** #7 Silly Numbers trained by James Ryerson and ridden by Jose Lezcano clipped heels and her rider was unseated.

After reviewing the race video and speaking to the riders involved in the judgment of the Stewards no further action was warranted. Decision was unanimous.

**Stewards Inquiry Race 7-** Inquiry into the start, #9 Verdant Pastures (Antonio Gallardo) breaks sharply towards the rail and makes solid contact with #7 The Eagle Is Gone (Dylan Davis) who then makes solid contact with #5 Saratoga Citizen (Tyler Gaffalione) and #4 Easy Way Out (Irad Ortiz, Jr.) on the inside. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident altered the finish of the race and #9 Verdant Pastures is disqualified from third and placed seventh. Decision was unanimous. New order of finish: 6, 4, 11, 5, 1, 7, 9, 2, 8.

**Equine Death Race 2-** #6 Cinder Block trained by Michael Pino and ridden by Kendrick Carmouche pulled up around the half mile pole and was taken off the track on the horse ambulance. Found to have a right front leg fracture and the horse was humanely euthanized. Claim was voided.

**Stewards Inquiry and Jockey Objection Race 6-** Jockey of the eighth place finisher #8 Put It Forward (Antonio Gallardo) claimed foul against third place finisher #5 Blue Pigeon (Jomar Torres) for alleged interference in the stretch. In the vicinity of the 1/16 pole #5 Blue Pigeon reacting to his riders left handed crop comes out and #8 Put It Forward has to steady, completely stopping his momentum while racing in contention. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident altered the finish of the race and #5 Blue Pigeon is disqualified from third and placed eighth. Decision was unanimous. New order of finish: 3, 1, 13, 7, 6, 2, 8, 5, 10, 11, 4, 12.
