**Stewards Inquiry and Jockey Objection Race 4-** Jockey of the second place finisher #16 D’Ambrosio (Javier Castellano) against the first place finisher #15 Zap Zap Zap (John Velasquez) for alleged interference in the stretch. In the vicinity of the 1/8 pole #15 Zap Zap Zap drifts out and brushes with #16 D’Ambrosio and then inside the 1/16 pole #16 D’Ambrosio drifts in and brushes with #15 Zap Zap Zap. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident did not alter the finish of the race and the race is official as is. Decision was unanimous.

**Stewards Inquiry Race 2-** Inquiry into the stretch run, in the vicinity of the 1/16 pole #7 Hy Brasil suffered a fatal musculoskeletal injury to the right front leg, stumbled sharply and unseated the rider. No other horses were involved in the incident and the Stewards made the race official as is.

**Equine Death Race 2- #7 Hy Brasil** trained by Gary Sciacca and ridden by Luis Reyes suffered a fatal musculoskeletal injury at the 1/16 pole and unseated the rider and was euthanized on track.
