**Stewards Inquiry and Jockey Objection Race 5-** Jockey of the second place finisher #1 Bree's Got Heart (Frankie Pennington) claimed foul against first place finisher #4 About That Base (Jose Ortiz) for alleged interference in the stretch. In the vicinity of the 1/16 pole #1 Bree's Got Heart racing on the rail and #4 About That Base racing outside brush at the seventy yard pole and the contact was from both the inside horse and the outside horse. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident did not alter the finish of the race and the race is official as is. Decision was unanimous.

**Stewards Inquiry and Jockey Objection Race 1-** Jockey of the second place finisher #5 It Must Be Nice (Jose Ortiz) claimed foul against the first place finisher #4 Lorimer Street (Manuel Franco) for alleged interference in the stretch. #5 It Must Be Nice and #4 Lorimer Street came together brushing lightly on two occasions inside the 1/16 pole. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this did not alter the finish of the race and the race is official as is. Decision was unanimous.

**Stewards Inquiry Race 8-** Inquiry into the start, #4 Radial Flyer (Rosario Montanez) stumbled leaving the starting gate and unseated the rider. After reviewing the race video in the judgment of the Stewards the race is official as is. Decision was unanimous.

**Stewards Inquiry and Jockey Objection Race 1-** Jockey of the third place finisher #6 Altesino (Jose Ortiz) claimed foul against first place finisher #7 Pursuer (Rajiv Maragh) for alleged interference at the start. After reviewing the race video and speaking to all the riders involved in the judgment of the Stewards no action was warranted. Decision was unanimous.

Inquiry into the start, #3 The Orphan Miracle (Angel Arroyo) swerved sharply to the right making contact with #4 Ransom Note, #5 Steady Heat and #6 Altesino. After reviewing the race video in the judgment of the Stewards this incident altered the finish of the race and #3 The Orphan Miracle was disqualified from fifth and placed last. Decision was unanimous. New Order of Finish: 7, 1, 6, 2, 5, 3.

Furthermore, "Rahy's Bandit" is disqualified from any part of the purse. Having appealed a stay has been granted
