Stewards Inquiry and Jockey and Trainer Objection Race 1- Jockey and the trainer of the third place finisher #5 Persuasive Devil (Eric Cancel) claim foul against the second place finisher #4 Midnight Trace (Jaime Rodriguez) for alleged interference in the stretch. In the vicinity of the 1/16 pole #4 Midnight Trace drifts out along with #5 Persuasive Devil and then #4 Midnight Trace shifts out in front of #5 Persuasive Devil approaching the wire. After reviewing the race video and speaking to all riders involved in the judgement of the Stewards no action was warranted. Decision was unanimous.

No Incidents Occurred

Jockey Movie Review Race 1- Stewards Stephen Lewandowski, Hugh Gallagher and James Edwards met with riders Jaime Rodriguez and Eric Cancel to review drifting out in deep stretch in relation to Stewards Inquiry and Jockey Objection. After review the Stewards issued Jaime Rodriguez a suspension of five NYRA racing days for not making a strong effort to correct his horse from drifting.

Jockey Movie Review Race 5- Stewards Stephen Lewandowski, Braulio Baeza, Hugh Gallagher and James Edwards met with riders Junior Alvarado and Kendrick Carmouche to review the stretch run in the running of the fifth race. After review the Stewards took no action as film of the race was inconclusive and they stressed the safety of the rider and the horse.
