Stewards Inquiry and Jockey Objection Race 3- Jockey of the fifth place finisher #5 Sea Pebble (Rayan Gazader) claimed foul against fourth place finisher #3 Head Shrinker (Hector Diaz, Jr.) for alleged interference in the vicinity of the 1/2 pole. #5 Sea Pebble while in tight dropped in making contact with #3 Head Shrinker causing her own problems. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards no further action was warranted and the race was official as is. Decision was unanimous.

Incident Race 2- #2 Kid Cruz trained by Linda Rice and ridden by Cornelio Velasquez was pulled up at the 1/4 pole and taken off on the horse ambulance. Claim was voided.
