**Stewards Inquiry and Trainer Objection Race 5-** Trainer of the second place finisher #1 The Brown Bomber (Manuel Franco) claimed foul against the first place finisher #2 Adirondack Dream (Hector Diaz, Jr.) for alleged interference in the stretch. In the vicinity of the 1/8 pole #2 Adirondack Dream shifts in at the same time as #1 The Brown Bomber shifts out. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident did not alter the finish of the race and the race is official as is. Decision was unanimous.
