Stewards Inquiry and Jockey Objection Race 8- Jockey of the fourth place finisher #3 Torrent (Jose Lezcano) claimed foul against the second place finisher #8 Sounds Delicious (Junior Alvarado) for alleged interference in the stretch. In the vicinity of the 1/16 pole #8 Sounds Delicious reacting to a right handed crop drifts in and makes contact with #3 Torrent stopping his momentum along the rail. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident altered the finish of the race and #8 Sounds Delicious is disqualified from second and placed fourth. Decision was unanimous. New order of finish: 7, 4, 3, 8, 6, 5, 1.

Stewards Inquiry and Jockey Objection Race 10- Jockey of the second place finisher #5 Enticed (Junior Alvarado) claimed foul against the first place finisher #9 Vino Rosso (John Velazquez) for alleged interference in the stretch. In the vicinity of the 3/16 pole #9 Vino Rosso shifts in and contact is made with #5 Enticed. After reviewing the race video and speaking to the riders involved in the judgment of the Stewards this incident did not alter the finish of the race and the race is official as is. Decision was unanimous.

Equine Death Race 4- #4 Milo Milo trained by Naipaul Chatterpaul and ridden by Luis Reyes was pulled up at the 5/8 pole and taken off on the horse ambulance. Was later found to have a right front leg fracture and was humanely euthanized.
