**Stewards Inquiry and Jockey Objection Race 2-** Jockey of the second place finisher #3 Inca Saint (Gabriel Saez) claimed foul against first place finisher #7 Pass the Dice (Irada Ortiz, Jr.) for alleged interference in the stretch. In the vicinity of the 1/16 pole #7 Pass the Dice drifts out and makes contact with #3 Inca Saint carrying him out. #3 Inca Saint goes on to finish second by a nice. After reviewing the race video and speaking to all riders involved in the judgment of the Stewards this altered the outcome of the race and #7 Pass the Dice is disqualified from first and placed second. Decision was unanimous. New order of finish: 3, 7, 2, 6, 1, 4, 5.

No Incidents Occurred

**Jockey Movie Review Races 2 and 5-** Stewards Stephen Lewandowski, Braulio Baeza and James Edwards met with rider Irada Ortiz, Jr. to review him drifting out on #7 Pass the Dice in race 2 and breaking from the rail and coming out four paths after the start on #1 Zen Papa in race 5. After review the Stewards issued a \$2,000 fine for the actions in race 2 and stressed the safety of both the horses and riders for race 5.
