Stewards Inquiry and Jockey Objection Race 2- Rider of the #7 Magic Mojo (Jose Lezcano) claimed foul against the rider of the #3 Price Talk (Manuel Franco). In the stretch run #3 Price Talk under a left-handed crop drifts out several paths bumping into #7 Magic Mojo who then bumps #1 Leading West (Irado Ortiz, Jr.) causing him to lose valuable ground. After reviewing the race video and speaking to the riders involved in the opinion of the Stewards the incident affected the outcome of the race and #3 Price Talk is disqualified from first and placed fifth behind #1 Leading West. New Order of Finish: 6, 10, 7, 1, 3.

Following formal film review with the riders involved the Stewards issued a ruling against Manuel Franco.

Stewards Inquiry and Jockey Objection Race 1- Rider of the #5 Bundibunan (Jose Ortiz) claimed foul against the rider of #6 Value Engineering (Javier Castellano). Inside the 1/16 pole #6 Value Engineering comes out several paths in front of #5 Bundibunan who is forced to take back. After reviewing the race video and speaking to the riders involved in the opinion of the Stewards this incident did affect the outcome of the race and the #6 is disqualified from second and placed third behind the #5. New Order of Finish: 7, 5, 6, 4.

Following formal film review with the riders involved the Stewards issued a ruling against rider Javier Castellano.

Stewards Inquiry, Trainer Objection and Jockey Objection Race 3- Connections of the #4 The Rock Says (David Cohen) claimed foul against the #1 Universal Payday (Tyler Gafflione). Inside the 1/8 pole #1 Universal Payday comes in under a right-handed crop to the #4 The Rock Says who checks briefly. After reviewing the race video and speaking to the riders involved in the opinion of the Stewards the incident did not affect the outcome of the race and the race was made official as is.
