The New York State Gaming Commission, Division of Gaming (NYSGC) has reviewed an incident that occurred on August 29, 2021, at Rivers Casino and Resort, operated by Capital Region Gaming, LLC (Rivers), during which an underage person was allowed access to the casino gaming floor and participated in gaming activity.

On August 30, 2021 at approximately 0100, Rivers Security notified the NYSGC that an underage individual gained access to the gaming floor through the Elevator Entrance. The underage individual, later identified as [REDACTED] (DOB: [REDACTED]), approached Rivers Security Officer [REDACTED] and presented a Signature Rush Rewards card, which belongs to [REDACTED]. After gaining access to the gaming floor, [REDACTED] buys cheques from the cage for gaming (he is seen on camera handing \$80 to Rivers Cage Cashier [REDACTED]). [REDACTED] then walks to Pit [REDACTED] where he participates in gaming activity on Blackjack (BJ) [REDACTED] and Roulette (AR) [REDACTED]. [REDACTED] was observed [REDACTED] gaming twenty-nine times. [REDACTED] was not observed consuming any alcohol. [REDACTED] spent a total of fifty-five minutes and thirty-one seconds on the gaming floor before being escorted to the Rivers Security Office by Rivers Security Supervisors [REDACTED], [REDACTED], and [REDACTED].
